FOREWORD

All potential contestants should pro-actively contact their country's National Federation and/or National Olympic Committee at their earliest opportunity, if not already in contact. National Olympic Committees (NOC), and in some case National Federations (NF), are responsible for organizing and providing athletes' and caddies' travel, transportation, accommodation, accreditation, etc.

Additionally, each National Olympic Committee will have important dates and processes of its own, separate from the IOC's and IGF's.

QUALIFICATION SYSTEM

- The **Qualification System** for Golf may be found on the IGF website.
- In accordance with the Olympic Charter, entry of a qualified athlete is up to his/her National Olympic Committees (NOCs)

Men's end of qualification period: 17 June 2024
 Women's end of qualification period: 24 June 2024

OLYMPIC GOLF RANKINGS (OGR)

 Paris <u>2024 Olympic Golf Rankings and Reallocation Reserve Lists</u> are published every Tuesday on IGF website.

VENUE

- The Albatros Course of Le Golf National (https://www.golf-national.com/en/) is situated to the southwest of Paris, near Versailles, 41km from the Olympic Village.
- Paris 2024 Organising Committee for the Olympic Games has communicated that average travel times between Le Golf National and the Olympic Village are expected to be approximately 60 to 75 minutes.
- The Olympic Village is located 7 km north of the center of Paris, overlapping the communes of Saint-Denis, Ile Saint-Denis and Saint-Ouen. https://goo.gl/maps/ULATD8YwEavhkBxj8
- The course will be played as a par-71 for the men's event and a par-72 for the women's event.
- It has previously hosted the French Open since 1991, Ryder Cup in 2018 and World Amateur Team Championships in 1994 and 2022.

EVENT FORMAT

- 72-hole individual stroke play with no cut.
- Medals will be awarded for first, second and third place to the lowest three individual finishers in each competition based on cumulative score after the completion of the event. Any ties for the first, second or third place finishers will be determined by play-off(s) as necessary.

COMPETITION SCHEDULE

• Approximate tee times for all rounds will be 9:00 a.m. to 12.30 p.m. in groups of three off the 1st tee only, barring weather or unforeseen circumstances.

SERVICES

- The Olympic Village will provide all necessary services (restaurants, gym, medical center, etc.), and recreational activities for the athletes, caddies, and team officials in a unique, comfortable, and attractive environment, which is both safe and secure.
- Athletes and caddies will be accommodated at the Olympic Village unless otherwise organized by their National Olympic Committee.
- The Athlete Transport system between the Olympic Village and le Golf National currently consists of buses operating on a set schedule on both practice and competition days. Discussions continue between the IGF and the Organising Committee regarding potential alternatives.
- Should an athlete decide, in agreement with their National Olympic Committee, not to stay in the Olympic Village, it is the National Olympic Committee's or the athlete's responsibility to obtain and pay for alternative accommodations and transport.
- The golf venue perimeter will be secure and accessible only to vehicles holding a Vehicle Access and Parking Permit (VAPP). Athletes staying outside the Olympic Village are highly encouraged to organise such VAPPs with their National Olympic Committees as soon as possible.
- In addition to the athletes' personal accreditation, one "P" category accreditation has been allocated to each golf athlete for use by his/her coach/entourage, providing access to the golf venue and specific athlete preparation area only. The choice to use this accreditation rests entirely with the athlete and in no case with the National Olympic Committees.

IGF ATHLETE FRIENDS & FAMILY TICKETING PROGRAMME

- The IGF is happy to provide each competing athlete with up to 4 tickets per golf session in which the athlete is participating for use by his/her family and friends.
- "On Location" is the Official Hospitality Provider of the Paris 2024 Olympic Games offering hospitality packages including tickets, accommodation, and access to hospitality experiences around the Games. ANTI-DOPING

- Starting from 13 weeks prior to the Paris 2024 Olympic Games, the IGF is recognised as the In-Competition and Out-of-Competition Testing Authority and will manage the Registered Testing Pool (RTP) for the Olympic Games Athletes in accordance with IGF Anti-Doping Policy.
- In cooperation with the Professional Tours and National Anti-Doping Agencies, the International Testing Agency (ITA), on behalf of IGF, will conduct tests on all the qualifying athletes. Based on the Olympic Golf Ranking (OGR), all qualifying athletes will be included in the IGF's Olympic RTP and will be contacted individually and provided with specific anti-doping information.
- IOC Anti-Doping Rules for Paris 2024 Olympic Games are available and published on the IGF's website.
- The Anti-Doping Program, including Therapeutic Use Exemption (TUE) application and recognition process, will be published early 2024.
- The IGF Anti-Doping Handbook will be published early 2024.
