Field: Up to 78 Players

Format of Play: 54 Hole Individual Stroke Play Competition

Eligibility:

Female amateur players of Asian nationality ages 13-18 at the time of the event (or born between January 1, 2007 and December 31, 2012), who are not yet in college. Participants will be invited or can apply. In the latter case, selection will be determined based on rankings, handicaps, and slot availability.

Yardage: 6,492 yards (measured to the center of the green)

Player Benefits:

The top 3 players and ties will receive an invitation to the Hilton Grand Vacations ANNIKA Invitational presented by Rolex in the United States in 2026, as well as a \$1,500 travel reimbursement for the event. If a qualifying player turns professional or enrolls in university after securing their spot, they will forfeit the right, and it will be offered to the next eligible player. If a rights-holder declines to participate in the world championship, the right will not be passed down to the next player.

World Amateur Golf Ranking: This event is a WAGR points eligible tournament.

Tournament Entry Fee: 35,000 Japanese Yen (yen)

Entry fee includes:

- Green fee, caddie fee, and golf cart fee during each tournament round.
- Two trays of range balls daily during tournament days (October 14 17).

- ① 9-hole round or 18-hole round.
- ② Desired round time (early/late). *The last start for a 9-hole round is 12:00 PM.
- ③ Round members (if applying with 2 players or fewer, you will be paired).

Fees Before Tournament Week:

Until end of September: 18,500 yen (includes caddie, cart, and tax)

October: 19,500 yen (includes caddie, cart, and tax)

*Weekdays only.

*Reservations accepted per group only.

- *For a 2-some, an additional caddie fee of 4,400 yen (tax included) per person will apply. For a 3-some, an additional caddie fee of 1,100 yen (tax included) per person will apply.
- *The greens used may differ from those on the tournament days. To book a practice round, please contact the Tournament Office (info@annika-br31.jp).

Distance Measuring Device:

Measuring devices are allowed but must be in non-slope mode (slope function not permitted).

Use of Caddies:

The use of caddies and carts is mandatory. However, players must walk the course during the official tournament rounds. They can ride during the practice round. Carts must be driven only by caddies. Electric push/pull carts are not allowed.

Official Bus:

During the tournament period, transportation will be provided between the official hotel and the golf course. (Please check the shuttle bus schedule posted at the hotel or the course.)
